### Tonya Hills Awarded the 2016 Horace Mann/Louisiana Association of Principals \$1,000 Aspiring Principal Scholarship

Mrs. Tonya Hills, 4th grade math, science, and social studies teacher at Hattie A. Watts Elementary in St. Mary Parish, has been awarded the 2016 Horace Mann/LAP \$1,000 Aspiring Principal Scholarship. This \$1,000 scholarship is

presented every year to a teacher, counselor, or curriculum coordinator who has an interest in becoming a principal or is currently working toward their principal certification. Applications are taken from all across Louisiana, and the applicant's principal must be a member of The Louisiana Association of Principals in order to be considered for the scholarship. The scholarship can be used to defray expenses for college tuition, continued professional growth, registration fees to state or national conferences, or textbook expenses. The recipient also receives a one-year LAP Aspiring Membership.

Tonya has been an educator for 11 years, serving at Raintree Elementary and Thomas Gibbs Elementary, in addition to Hattie A. Watts Elementary. Mrs. Hills serves as the school's facilitator of the "Leader in Me" Lighthouse Team. She efficiently trains all new school employees in the Seven Habits of Highly Effective People. During the training, Mrs. Hills teaches practical classroom applications of the habits and continues to



### From The Desk of The



### Hi all,

Happy Spring! I know that many of you are in the midst of testing and I hope that you had some time to rest and relax during Spring Break! We wish you all the best during this "testing season"!

In my last blog (which can be found on the LAP website www.laprincipals.org) I shared the letter that I had sent to BESE members and to Superintendent White regarding concerns about the ESSA plan that Superintendent White wanted to submit in April. During the special BESE meeting held on March 29<sup>th</sup>, 61 out of 69 District Superintendents asked that BESE delay submission to September 2017 and I shared that 96% of principals surveyed also felt the plan needed more work and that we should submit in September to allow for feedback from site-based Sadly, administrators. BESE members Superintendent White passed a motion to submit in despite the requests from Principals, Superintendents, Teachers and School Boards to submit in September. I would like to thank BESE members **Doris** Voitier, Kathy Edmonston, Thomas Roque and Dr. Lurie Thomason who did vote against the motion to submit the plan in April!

BESE further directed State Superintendent of Education John White, upon conclusion of the 30-day public comment period and in response to the public comments received, to incorporate the following into the draft plan:

Starting in 2018, school scores will be calculated using the system of points the plan currently establishes for 2025, except that "basic" on the LEAP, 18 on the ACT, and Silver on the WorkKeys should earn schools "C" level points, rather than "D" level points.

There should be no curve or forced distribution for letter grades starting in 2018.

The plan should establish a threshold lower than 100 out of 150 to attain a "A" grade in 2017-2018 and should include modest escalations of that threshold in 2022 and finally again 2025. Corresponding adjustments should be made at "B" and "C" levels.

Subgroup performance should be reported by percentile rankings in addition to academic performance; the plan should include a system of identifying low subgroup performance levels, including performance levels equivalent to D and F grades for that subgroup, as requiring "urgent intervention."

For reporting purposes, the plan should include a commitment to reporting letter-grade equivalents for the achievement indices and growth indices within the school rating system.

Three percent of Title I funding should not be set aside for Direct Student Services but should be allocated to every district per the traditional Title I formula, provided that funds are spent in line with requirements for the supplemental course allocation. Furthermore, the LDE should study access to courses for students in low-income, rural, or struggling schools and may make recommendations in future years for intervention in schools failing to provide course access to students.

The LDE should study and consider the effect on student learning of no longer requiring Biology and U.S. History end-of-course examinations, presenting findings no later than the June 20-21, 2017, BESE Committee and Board meetings.

The Interests and Opportunities indicator should include a menu of means by which schools could demonstrate success; the LDE should convene school system administrators to develop the measures necessary to create this indicator.

Prior to submission of the final state plan for federal review, the LDE shall convene a discussion with diverse stakeholders, including representatives of civil rights, business and professional organizations representing educators, school boards and charter schools.

It is a shame that Superintendent White and a majority of the BESE members show so little value for the leaders of our districts, our schools and our students, that they would totally ignore the request to have more feedback and buy in from the people who will be required to implement the plan. Even with the BESE directive listed in the last bullet above, Superintendent White still submitted the plan on April 15<sup>th</sup> without meeting with all of the groups listed, so even the motion that directed him to do so was not honored.

I would also like to point out that the Subgroup performance bullet will identify approximately 1000

out of a total of 1400 schools as needing urgent intervention (this will be designated on the school report card)—however the plan does not stipulate any support from the State for schools that receive that label or any details about what urgent intervention means for schools that receive that label.

We must continue to ask BESE members and Superintendent White to revise the plan, even though it was submitted to the USDOE, there is still an opportunity to amend prior to it becoming policy in Louisiana. The BESE board has set the June 20-21<sup>st</sup> BESE meetings as the meeting to approve policy (specifically accountability changes) and we will be sending some specific suggested changes for your consideration prior to that meeting. I will be providing you with more information during the next month on areas that we think need revision, and we encourage you to attend the June meeting if at all possible.

We are at a critical time in Louisiana! We have constantly changing rules and а diminishina workforce--and the most recent action Superintendent White and a majority of the BESE board signify that it is more important than ever to have the Principal's voice heard on key education issues. Please encourage your co-workers to become members of LAP--the more members we have the more our voice is heard! We are the only organization that is affiliated with the national principal's organizations (NAESP and NASSP) and we advocate for principals/site-based administrators at the national level also!

In addition to the concerns regarding the Louisiana ESSA plan, the 2017 Legislative Session

began this past week and LAP will be busy making sure your voice is heard! We will have legislative updates on our website and we encourage you to check out the information on upcoming bills and legislation that will affect schools and their leaders.




